In the same way homeowners borrow money in the form of a mortgage to finance the purchase of a home, a school district borrows money in the form of bonds to finance the design, construction, expansion, and renovation of schools.

Bond Election 2004 - \$6,500,000

Why Call for a Bond Now?







To Prepare For Growth

- To improve the safety and infrastructure of current facilities as student enrollment grows and technology changes.
- To Take Advantage of the Current Financial Environment
 - Construction prices rise every year, causing projects to become more expensive over time
 - Interest rates are decreasing, making it less costly to finance bonds
 - Homestead exemptions increased, which lessens the burden of the taxpayer
- To Address the Concerns of the District
 - The Maintenance and Operations budget cannot handle the repairs and upgrades necessary to fix the existing buildings

WR Needs Assessment Committee


- 26 members consisting of administrators, teachers, parents, community people, and business people met 3 times (Sept. 26th, Oct. 10th, and Oct. 23rd)
- Conducted walk-throughs of the facilities on the existing elementary campus and existing band hall
- Architects joined the committee to listen to the concerns from the committee to create preliminary drawings
- Financial agent joined the committee to show how much money a bond can be called for and how it affects homeowners
- Committee made a formal recommendation for the board to call a bond election for \$26,403,037



Brian Grubbs attended a Needs Assessment Committee meeting to discuss the amount of money a bond can currently raise for West Rusk. The following information is from his findings:

- West Rusk CCISD has been awarded a "Superior" rating in Texas' School FIRST accountability system. This prestigious rating demonstrates WRCCISD's exceptional financial management practices and effective allocation of resources.
- 2023-2024 I&S Tax Rate is currently \$0.3200. Bond 2024 proposal would raise this amount by \$0.1585 to \$0.4785 in order to raise \$26,403,037.

You are eligible to register if:

- You are a US Citizen;
- You are a resident of the county;
- You are at least 17 years & 10 months of age;
- You have not been declared by a court of law to be either totally, or partially mentally incapacitated, AND
- You have not been convicted of a felony, or, if convicted, must have (1) fully discharged the sentence, including any term of incarceration, parole or supervision, or (2) been pardoned or otherwise released from the resulting disability to vote
